
# ANTITERRORISM FORCE PROTECTION

# U.S. Army FORCE PROTECTION PROGRAM AND PILLARS





U.S. Army Definition Includes:

# ARMY FORCE PROTECTION PROGRAM PRIORITIES FOR COMMANDERS

- ★ **DEVELOP COMPREHENSIVE PROGRAMS**
  - ❖ **CONSIDER ALL POSSIBLE THREATS/VULNERABILITIES**
  - ❖ **EMPLOY INTEGRATED APPROACH**
  - ❖ **COORDINATION REQUIRED**
  
- ★ **EMPHASIZE LEADERSHIP & INDIVIDUAL RESPONSIBILITIES**
  - ❖ **RESPONSIBILITY FIXED ON COMMANDERS**
  - ❖ **TRAINING & AWARENESS (CDR TO INDIVIDUAL)**
  
- ★ **INCLUDE FP AS PRIORITY CONSIDERATION**
  - ❖ **IN ALL PLANS, OPERATIONS & ACTIVITIES**
  - ❖ **NEW CONSTRUCTION, ELECTRONIC SYSTEMS**
  
- ★ **IMPLEMENT DOD/JCS/DA STANDARDS AS ESTABLISHED**
  - ❖ **AR 525-13 IDENTIFIES 32 MANDATORY STANDARDS**

- **Review Subordinate Installation FP Programs**
- **Conduct Vulnerability Assessments of Each AMC owned Installation**

**★ VULNERABILITY ASSESSMENTS ARE ACCOMPLISHED BY ONE OF THE FOLLOWING METHODS**

- **JOINT STAFF INTEGRATED VULNERABILITY ASSESSMENT (JSIVA): Conducted by Defense Threat Reduction Agency (DTRA)**
- **HQAMC WILL INITIATE FORCE PROTECTION ASSESSMENTS IN SEP 99**
