
SUBJECT: Army Logistics Enterprise Integration Process Requirements/Subject Matter Experts (SMEs)

1. During the 16 July 2003 Army Logistics Enterprise Integration Executive Steering Committee meeting, we discussed a strategy to properly organize our key functional domains and experts to support our Enterprise Resource Planning (ERP) efforts/logistics architecture. The implementation of a disciplined functional SME construct will help ensure integration and synchronization of business processes. It is one of the critical enablers that will ensure Army logistics ERP solutions are optimally designed and integrated.
2. I am requesting your assistance in providing the necessary Subject Matter Experts (SMEs) to support logistics enterprise integration. These SMEs will provide support to the SAP processes of our logistics solution design and configuration. They will be part of a larger team consisting of management experts, industry consultants, and process experts supporting Global Combat Support System Army (GCSS Army), Product Lifecycle Management Plus (PLM+), Logistics Modernization Program (LMP) Industrial Base, and LMP Installation Supply and Maintenance programs. We need highly skilled Soldiers, civilians, and contractors who are forward thinkers and have experience with deployed operations, such as Operation Iraqi Freedom. These SMEs will be engaged in this process for an extended period of time. Those that are full time, will be duty stationed either at Ft. Lee, VA or Moorestown, PA. A total of 99 personnel are required. We have identified personnel to fill 46 positions; however, 53 SMEs are still needed to meet the overall requirement. The skill sets and grade ranges are indicated on the enclosed attachment. Also indicated/designated are the MACOM/Agencies we are asking to provide the indicated support. Part time personnel requirements will be addressed separately.
